Higher tax exemption limit, farm package lift Sensex over 430 points

Mumbai,
The Interim Budget's proposal to give full rebate to tax payers having annual income up to Rs 5 lakh and a farm package boosted the Indian equity market during the mid-afternoon trade session on Friday.

Observers took note of few key points in the Interim budget like sops to small farmers and announcement of a higher tax exemption limit as key factors which led to the market's rise.

According to HDFC Securities Deepak Jasani, the push to consumption by way of sops to farmers and middle class families resulted in buying in auto and FMCG stocks.

Sensex and Nifty advanced as Finance Minister Piyush Goyal presented the Interim Budget for 2019-20 in the Lok Sabha on Friday.

Sector-wise, healthy buying was witnessed in the auto, FMCG and capital goods stocks.

Not Vote on Account but Account for Votes: Chidambaram

New Delhi,
Former Finance Minister and Congress veteran P. Chidambaram on Friday described the Interim Budget as an "Account for Votes" and not a "Vote on Account" and said the Modi government has further weakened fiscal stability.

"It was not a Vote on Account but an Account for Votes," Chidambaram told the media here.

"It was a full-fledged Budget accompanied by an election campaign speech. By doing so, the government has trampled on time-honoured conventions," he said.

He added that the government had no hope of returning to power and had, therefore, "acted desperately and recklessly, and in violation of the Constitution."

He said the big takeaway was that the present government had "further weakened fiscal stability."
