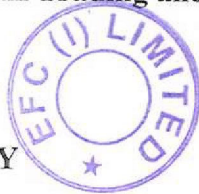

Abbott Napp had said that the questions to investigate are "what is inherited and how?" These questions motivated Mendel in his experiments. Between 1857 and 1864, Mendel undertook a series of plant breeding experiments in the monastery's garden, which were breathtaking for their brilliance in planning, observation and analysis, and also in the interpretation of the results.
